Final Plan Request – Storage Authorization at Longtom Lake Area

From the land use records in this office it is noted that the captioned land use permit expires on December 11, 2008. No further extensions, pursuant to Section 26(6) of the Mackenzie Valley Land Use Regulations, of this permit can be considered. Restoration, clean up and removal of equipment, materials, buildings, etc., must now be completed.

Pursuant to Section 29 of the Mackenzie Valley Land Use Regulations, you are now required to submit a final plan with the following content:

1. A map, normally at a scale of 1:50,000 showing your location, area, and distances of all land use operations. Sketches are acceptable but all maps must have the north indicator, scale and coordinates clearly marked.
2. A summary of the hectares utilized in each aspect of the land use operation; and
3. A calculation of land use fees.
