Hi Brett,

Thanks for the phone call and providing us this opportunity to get our permit application back into the system. In regard to this agreement with YKDFN, I do not fully understand the need as I, as are most exploration companies, am willing to communicate and provide them copies of reports. And we have never stopped them or confronted them onsite. I'm also confused as to who they represent – all First Nations? As far as the Archaeological study, now I am also confused. The Board stated the permit would be subject to a study. Can you tell me the scope of this as the way Todd talked, it would only be specific to new areas we plan to drill and work? Would this mean there are different requirements? And I have difficulty as to why an agreement is so secret – I don't understand why as we have always been open to everything. My email of December 22, 2011 essentially outlines a number of issues and concerns. Any agreement we sign will be respected and implemented. It would be difficult and onerous to do so in the present draft terms of agreement. When I met with Todd, he was amicable and we will continue to discuss and determine what is essential to an agreement. Possibly I am over reacting and some issues may not be as onerous as they appear. If that's the case, then we need to tone down the agreement. It may be as simple as changing some wording.

The changes have been quite severe. As I told you before I have partners and directors that I am obliged to review with and seek approval prior to committing the company. We are a small company, and the Monument property is primarily still in exploration and thus far we have not found a 'barn burner' although we do have encouraging results. We have not drilled all the known targets – the balance being mainly water targets. The past cost to work at this property is very high compared to other areas we explore and committing ourselves to even higher costs is a serious undertaking. I wish you would reconsider on some the costly items and possibly 'stage' the agreement with 'down the road' items in the event we have indications of production. Diamond exploration is high risk and very few explorationists are fortunate enough to make discoveries comparable to the current mines in NWT. The Monument property has been worked intermittently since 1992 and many millions of dollars have been spent in the NWT. Our supplies are all purchased locally and we never discriminated to qualified employees or contractors or expeditors etc. The WLWB, if you read the review, had already made stipulations regarding the Archaeological study and we would be obligated to comply with them first. There is too much confusion here and too onerous and just this agreement with you is going to be costly. It has to go back to the lawyer as my directors will not approve without a lawyer signing off on it. The HR requirements you request are more geared to a larger company... I will continue to work on this best I can. I wish you and yours a very happy holiday and we'll talk in the new year.
