1.1 The Permittee shall not conduct this land use operation on any lands not designated in the accepted application, unless otherwise authorized in writing by the Board. PLANS

2.0 26 (1) (b) - TIME

2.1 The Permittee's Field Supervisor shall contact a Land Use Inspector at the office of the Department of Indian Affairs and Northern Development, telephone number (867) 777-3361, at least forty-eight (48) hours prior to the commencement of this land use operation. CONTACT INSPECTOR

2.2 The Permittee shall advise a Land Use Inspector when on the completion of the land use operation (a) a plan for removal or storage of equipment and materials, and (b) when final clean-up and restoration of the land used will be completed. REPORTS BEFORE REMOVAL

2.3 The Permittee shall complete all clean-up and restoration of the lands used prior to the expiry date of this Permit. CLEAN-UP

2.4 The Board reserves the right to impose closure of any area to the Permittee in periods when dangers to natural resources are severe. CLOSURE

3.1 The Permittee shall not use any equipment except of the type, size, and number that is listed in the accepted application, unless otherwise authorized in writing by a Land Use Inspector. ONLY APPROVED EQUIPMENT

3.2 The Permittee shall keep all garbage and debris in a covered container until disposed of. GARBAGE CONTAINER

3.3 The Permittee shall remove from Territorial lands all scrap metal, discarded machinery parts, barrels or building materials REMOVE WASTE MATERIAL

3.4 The Permittee shall burn all combustible garbage and debris in a container acceptable to the Land Use Inspector INCINERATION
