How long have you known you were not going to comply with the August 31, 2009 deadline?

You provided the Board with exactly one week to extend this deadline.

As you should be aware this is not an acceptable period of time to properly complete the Board's process for reviewing information and then making a determination.

This will now be the third or fourth time you have made a request for an extension for the temporary storage of ANFO.

Although I am pleased that your letter states the extension required would only be for a period of 30 days in my opinion this has become an unacceptable situation.

The extension request should have been sent to the Board at least 30 days prior to the deadline date of August 31. A note on DeBeers' file will be made regarding your inability to make this deadline.
