**Yellowknife Airport - Notification Period Water Licence MV2001L3-0012**

The Mackenzie Valley Land and Water Board (the Board) acknowledges receipt of your letter dated May 10, 2010 requesting to waive the 60 day notification period as per Part E, Item 1 of Water Licence MV2001L3-0012. The Board has reviewed this request and waives the 60 day notification period of this project.

The Board requests the following information be provided prior to the completion of construction:

- 1) Submission of an Abandonment and Restoration Plan for the existing Glycol Retention Facility for Board approval; and
- 2) Submission of an updated Glycol Mitigation and Operation Plan for Board approval.

As part of the approval to waive the 60 day notification period for the relocation the Glycol Retention Facility (GRF), the Board will be re-evaluating the Surveillance Network Program sample locations of the current Water Licence and may adjust the sites to reflect the change in the location of the GRF.

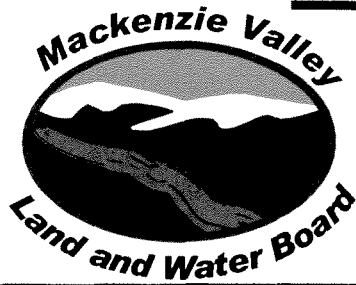

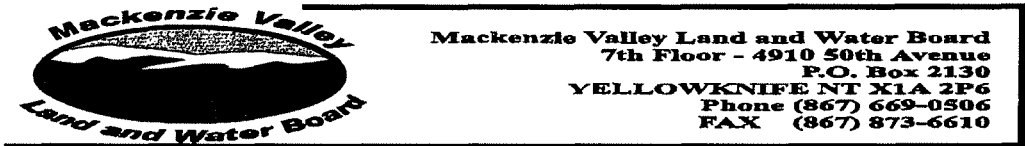
