Thank you for your letter of August 24, 2010.

In a letter dated August 11, 2010, from Tyree Mullaney, a number of options were presented that suggested that a renewal may not be forthcoming for some time. In preparing for obtaining the maximum available interim licence coverage Department of Transportation staff reviewed the Mackenzie Valley Land and Water Board's public registry. Several examples of amendment to Water Licence expiry dates were found including the amendment approval issued in the attached letter. On June 29, 2007 the Mackenzie Valley Land and Water Board issued an amendment approval to Teck Cominco's Type B water licence for Pine Point (see attached). This letter indicates that a 120 day amendment was issued as per Section 18(1)(b) of the Northwest Territories Waters Act.

The Department of Transportation, therefore, requests that such an amendment be issued for the Yellowknife airport. This period is requested in order to ensure adequate licence coverage in the event that the Board does not proceed with a licence renewal following the 73 day review period indicated in Ms. Mullaney's letter.
