Attached is Water Licence MV2008L3-0004 granted by the Mackenzie Valley Land and Water Board (MVLWB or the Board) in accordance with the *Northwest Territories Waters Act*. Water Licence MV2008L3-0004 has been approved for a period of five years commencing August 27, 2009 and expiring August 26, 2014. This Water Licence (MV2008L3-0004) does not permit the Hamlet of Enterprise to haul water from the town of Hay River, permission must be granted from the town as this would fall under their water licence.

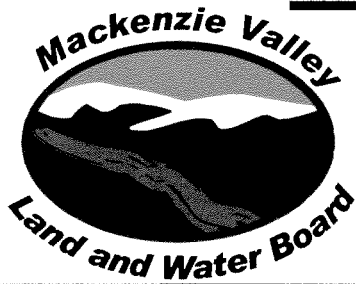
